TERMS AND CONDITIONS FOR TRADERS AT SEDGEMOOR VINTAGE SHOW

1. Applications for entry must be on the appropriate entry forms available from section stewards or at sedgemoorvintageclubltd.co.uk.
2. Copies of relevant insurance documents must be returned prior to admission.
3. All traders must book in with their section steward before 10am on days attending.
4. The duration of the show is from 10am – 5pm on both days. Vehicles are prohibited from moving on site between 10am and 5pm, unless accompanied by a steward.
5. Traders must be set up on site prior to the show opening at 10am and may not leave until the show closes at 5pm.
6. Wrist bands must be always worn. Otherwise, admission fees will apply. **NO EXCEPTIONS**
7. Code of Practice: SVC, exhibitors and members of the public are required to follow codes of practice in respect of fire precautions, health, hygiene, and safety etc. All persons must pay due regard to instructions from the stewards or SVC management and should always conduct themselves in a proper manner with no inconvenience to others.
8. No item of any nature is to be offered for sale in any part of the site without prior written consent from SVC. Trade & Craft accepted.
9. Entry to site: Each trader will be provided with TWO wrist bands for their stand. Extra bands may be collected upon request from the section steward.
10. Traders must set up where requested by the section steward. Returning traders will have priority for show field pitches. If space is limited, new traders may be required to set up adjacent to the pay gate, outside the main field.
11. Site-wide speed limit of 5 MPH.
12. Pitch locations will be marked out by the organisers. If you require a specific location / neighbouring trader, this must be advised in advance as changes cannot be made in the field.
13. The organisers decision is FINAL.

Failure to comply with these terms and conditions may result in refusal of entry or removal from the show.
